- 3) Two separate budget scenarios that show how the impact of 2% and a 4% increase in the housing charge would have on the following factors: Economic Housing Charge, Retained Earnings, total Co-op Income. In all options, we will be decreasing the retained earnings, but maintaining our replacement reserve above the \$90,000 threshold.





ARE WE KEEPING UP WITH THE COST OF LIVING? CAN WE AFFORD TO?








HOW MUCH OF THE BUDGET IS ACTUALLY SPENT?
